Product Description: UiPath Insights is a web application that serves as a platform for data modeling and analytics using a combination of available business metrics and operational insights.

Notes: Specific user scenarios were tested to ensure critical user paths were included in the VPAT. All application content was not tested, but rather a crucial sampling of content was used for test cases.

Evaluation Methods Used: Software Test Process for WCAG 2.2 AA was used (based on Trusted Tester v5, WCAG 2.0 AA, WCAG 2.1 A-AA, WCAG 2.2 and Section 508 Software testing).

The following testing tools were used on a Windows 10 desktop and Chrome Browser: Accessibility Insights for Windows v1.1, Color Contrast Analyzer, NVDA v2024.1, Axe® accessibility testing tools: axe Auditor and the axe DevTools browser extension and external keyboard.

Testing was performed by Certified Professional in Accessibility Core Competencies from Deque and by certified Trusted Testers (v5) from New Editions Consulting, Inc.

A mouse user can click these buttons, but a keyboard user is unable to use tab or arrow keys to access these buttons. The clickable bars and numbers under graphs are not keyboard accessible. These can only be accessed via mouse. The column options menus in all tables are not keyboard accessible. These can only be accessed via mouse. Keyboard only users are unable to perform the same actions as mouse users when accessing and executing links.
